Section 3. Hazards Identification

Appearance and Odor :	Emergency Overview Amber. Liquid. Hydrocarbon.
Health Hazards	Vapors may cause drowsiness and dizziness. Harmful: may cause lung damage if swallowed.

General Information	: In general no treatment is necessary, however, obtain medical advice.	
Inhalation	: Remove to fresh air. If rapid recovery does not occur, transpor to nearest medical facility for additional treatment.	
Skin Contact	: Remove contaminated clothing. Flush exposed area with wate and follow by washing with soap if available.	
Eye Contact	 Flush eyes with water while holding eyelids open. Rest eyes fo 30 minutes. If redness, burning, blurred vision, or swelling persist, transport to the nearest medical facility for additional treatment. 	
Ingestion	 If swallowed, do not induce vomiting: transport to nearest medical facility for additional treatment. If vomiting occurs spontaneously, keep head below hips to prevent aspiration.

Do not discharge extinguishing waters into the aquatic environment. Do not use water in a jet. Wear full protective clothing and self-contained breathing apparatus. Keep adjacent containers cool by spraying with water.

Section 6. Accidental Release Measures

Observe all relevant local and international regulations.

Protective measures :	Avoid contact with spilled or released material. Immediately remove all contaminated clothing. Prevent from spreading or entering drains, ditches or rivers by using sand, earth, or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by using fog sprays. Take precautionary measures against static discharge. Ensure electrical continuity by bonding and grounding (earthing) all equipment. Monitor area with combustible gas indicator.
Clean Up Methods :	For small liquid spills (< 1 drum), transfer by mechanical means to a labeled, sealable container for product recovery or safe disposal. Allow residues to evaporate or soak up with an appropriate absorbent material and dispose of safely. Remove contaminated soil and dispose of safely. For large liquid spills (> 1 drum), transfer by mechanical means such as vacuum truck to a salvage tank for recovery or safe disposal. Do not flush away residues with water. Handling	:	Extinguish any naked flames. Do Not smoke. Remove ignition sources. Avoid sparks. Avoid contact with skin, eyes, and clothing. Electrostatic charges may be generated during pumping. Electrostatic discharge may cause fire. Ensure electrical continuity by bonding and grounding (earthing) all equipment. Restrict line velocity during pumping in order to avoid generation of electrostatic discharge (<= 1 m/sec until fill pipe submerged to twice its diameter, then <= 7 m/sec). Avoid splash filling. Do NOT use compressed air for filling, discharging, or handling operations.
Storage	:	Must be stored in a diked (bunded) area. Bulk storage tanks should be diked (bunded). Storage Temperature: Ambient. Maximum storage time: 6 months
Product Transfer	:	Electrostatic charges may be generated during pumping. Electrostatic discharge may cause fire. If positive displacement pumps are used, these must be fitted with a non-integral pressure relief valve.
Recommended Materials	:	For containers, or container linings use mild steel, stainless steel. For container paints, use epoxy paint, zinc silicate paint.
Unsuitable Materials Container Advice	:	Avoid prolonged contact with natural, butyl or nitrile rubbers Containers, even those that have been emptied, can contain explosive vapors. Do not cut, drill, grind, weld or perform similar operations on or near containers.


